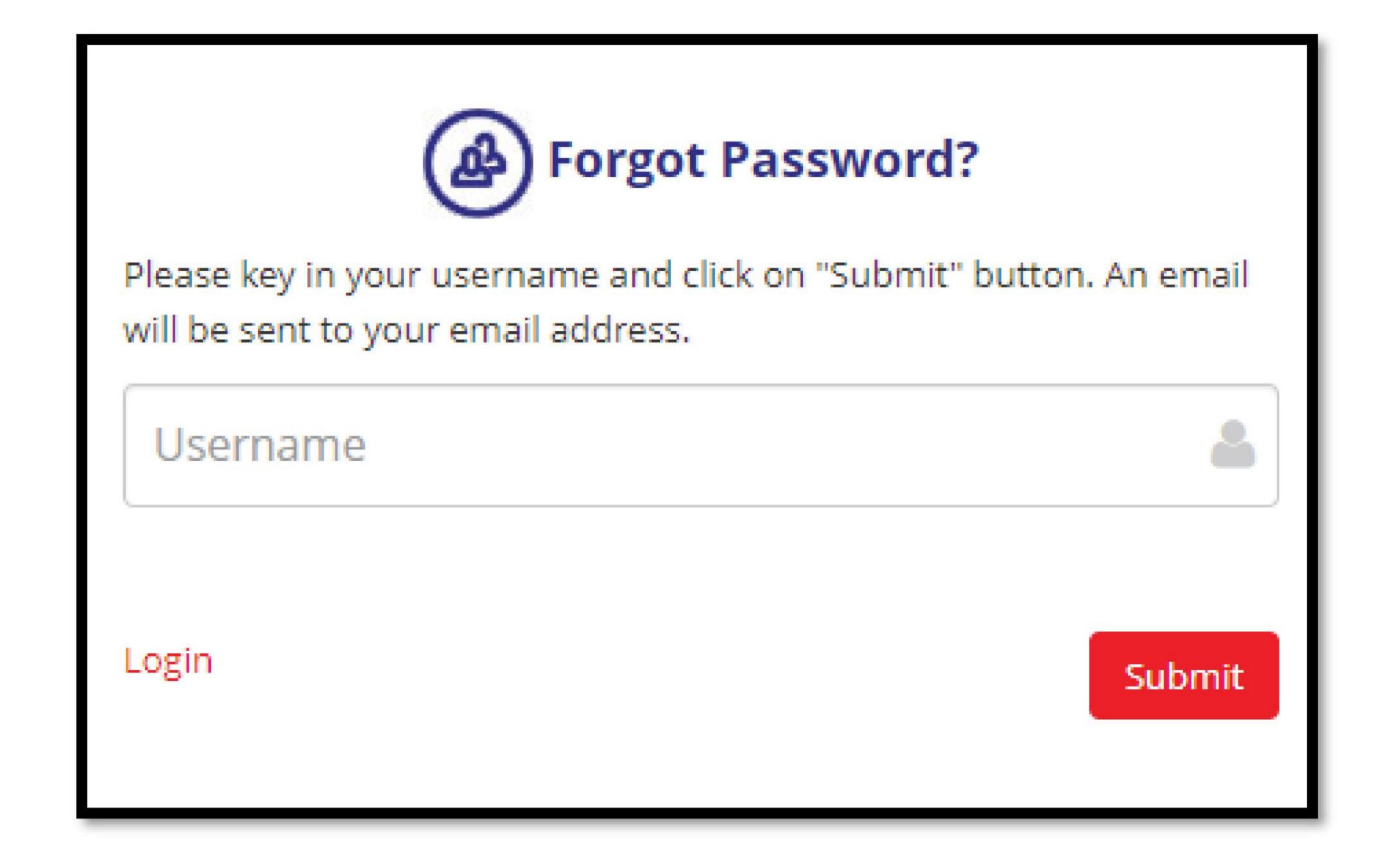
4.0 FORGOT PASSWORD

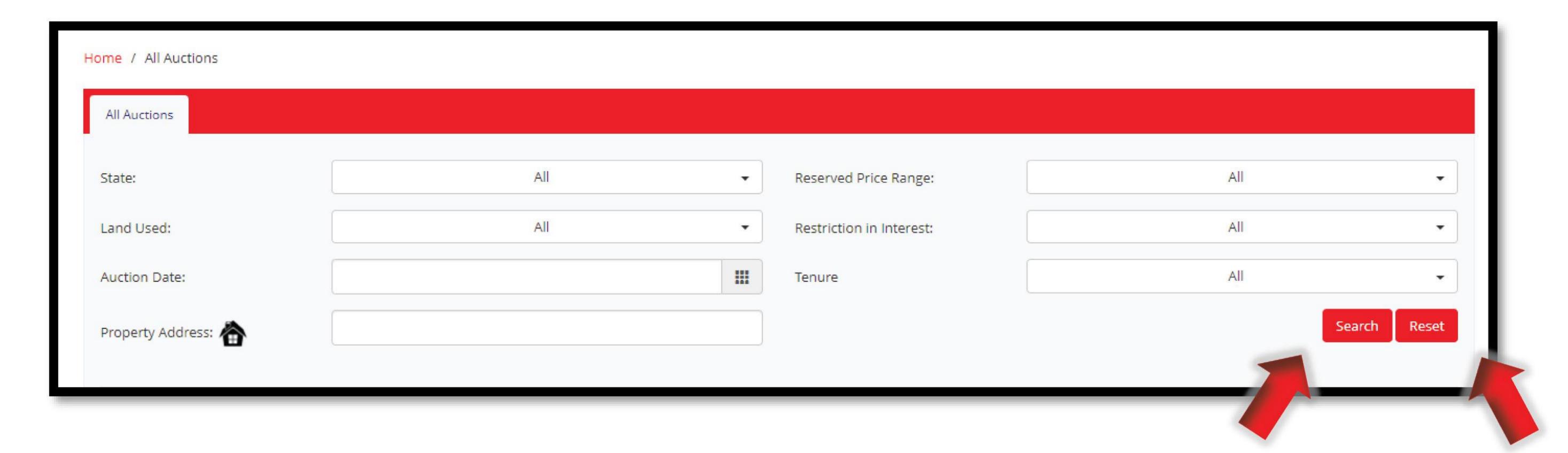

5.0 MAIN PAGE - e-LELONG SYSTEM HIGH COURT OF MALAYA

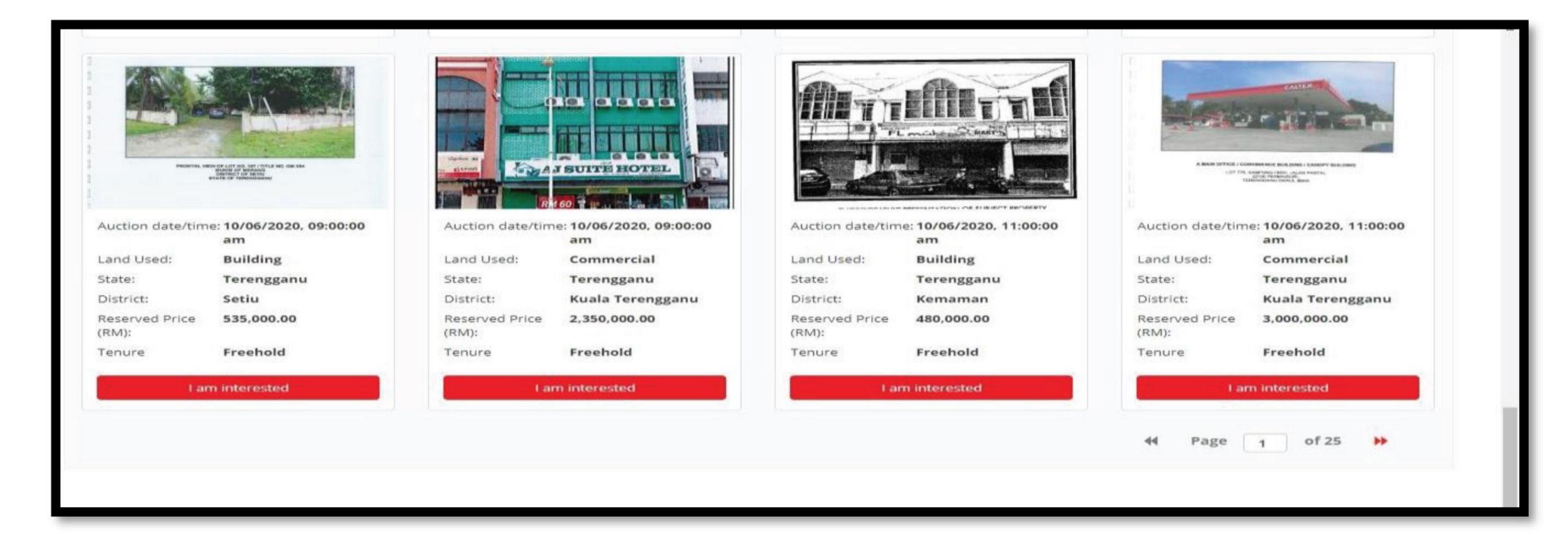
- 5.1 Main Page by default, will display the upcoming auction beginning the next day. The properties layout is according to auction date/time.

8.0 User can review property selection status and bidding payment status on the homepage. Click My Bids. Then, click Upcoming. [Figure 8.0]



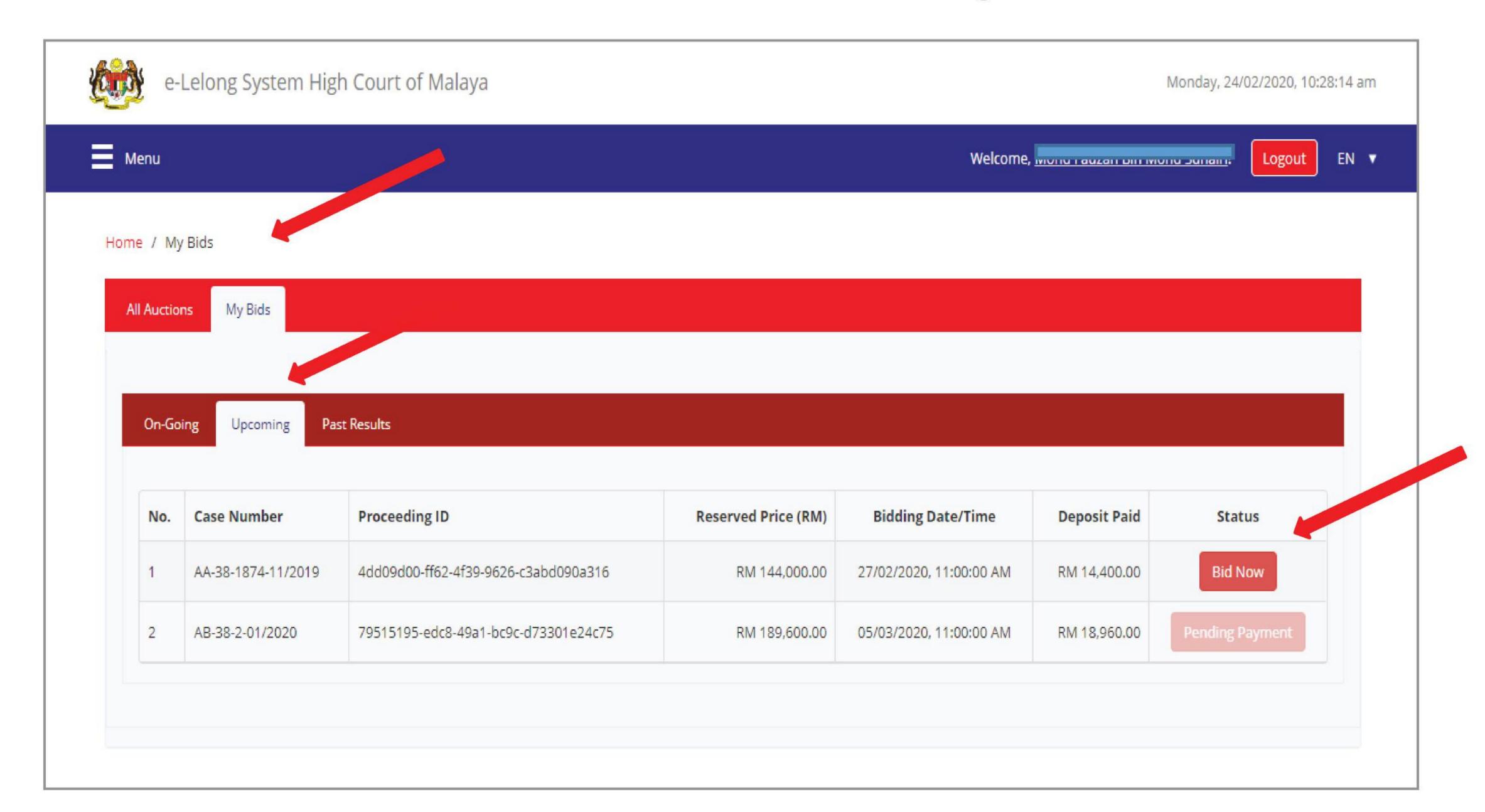

- **9.0** Once the bank draft is sent to Court, the Registrar of Pusat Operasi e-Lelong will approve the payment in the system. User may check the status of bidding payment on the homepage. Click **My Bids**. Then, click **Upcoming**. The status will show **Bid Now**. [Figure 9.0]
- 10.0 User is given the option to bid ahead/earlier than the auction date. To set a price, click Bid Now. Then, click on [+] and refer to figure 14.0

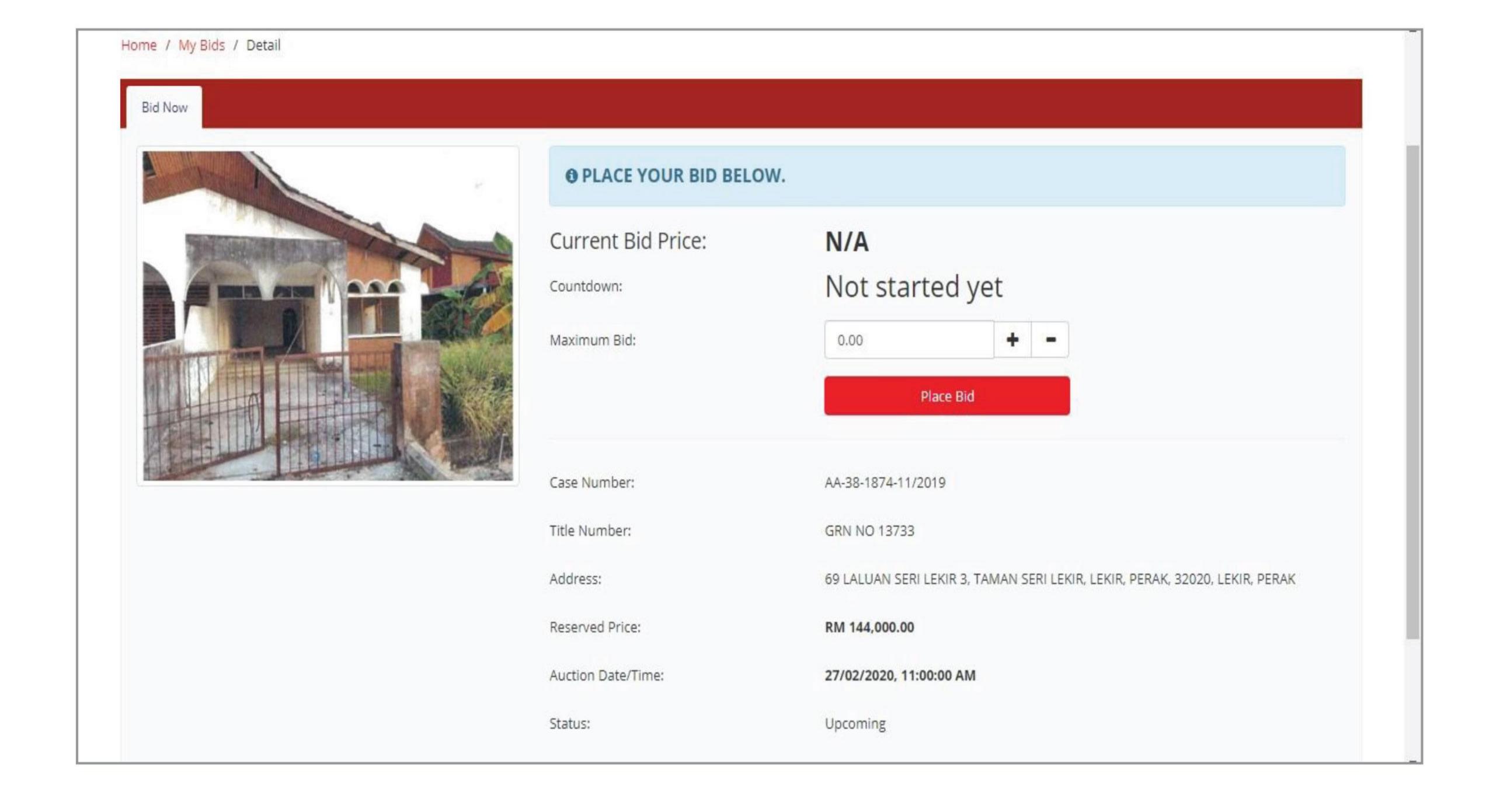

11.0 BIDDING PROCESS

11.1 On auction day, User is advised to log into the website around 5-10 minutes earlier than the fixed auction time. Click My Bids, Upcoming and Bid Now [10.0]

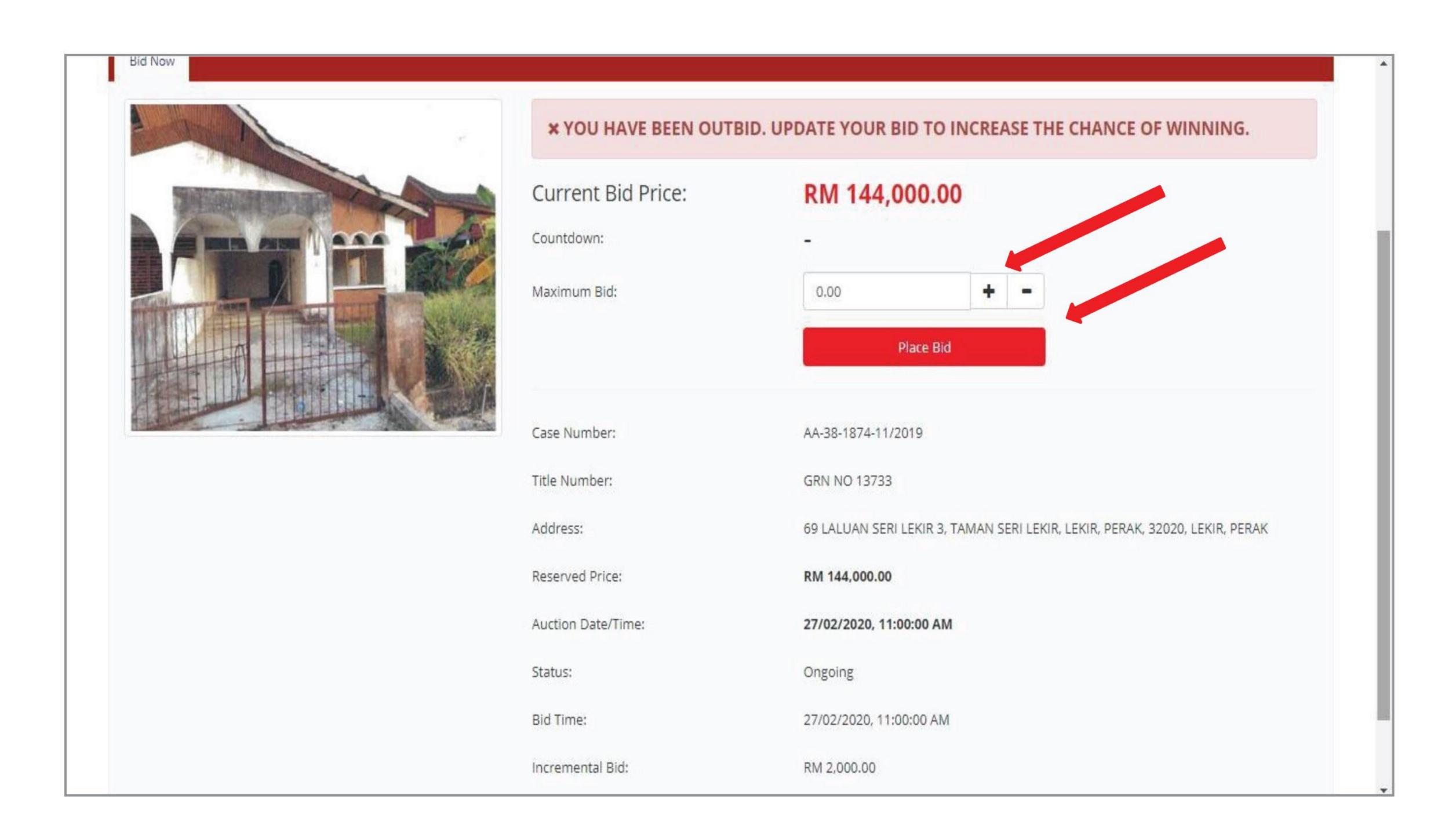
[Figure 12.0]

12.0 Bidding page will appear. [Figure 12.0]

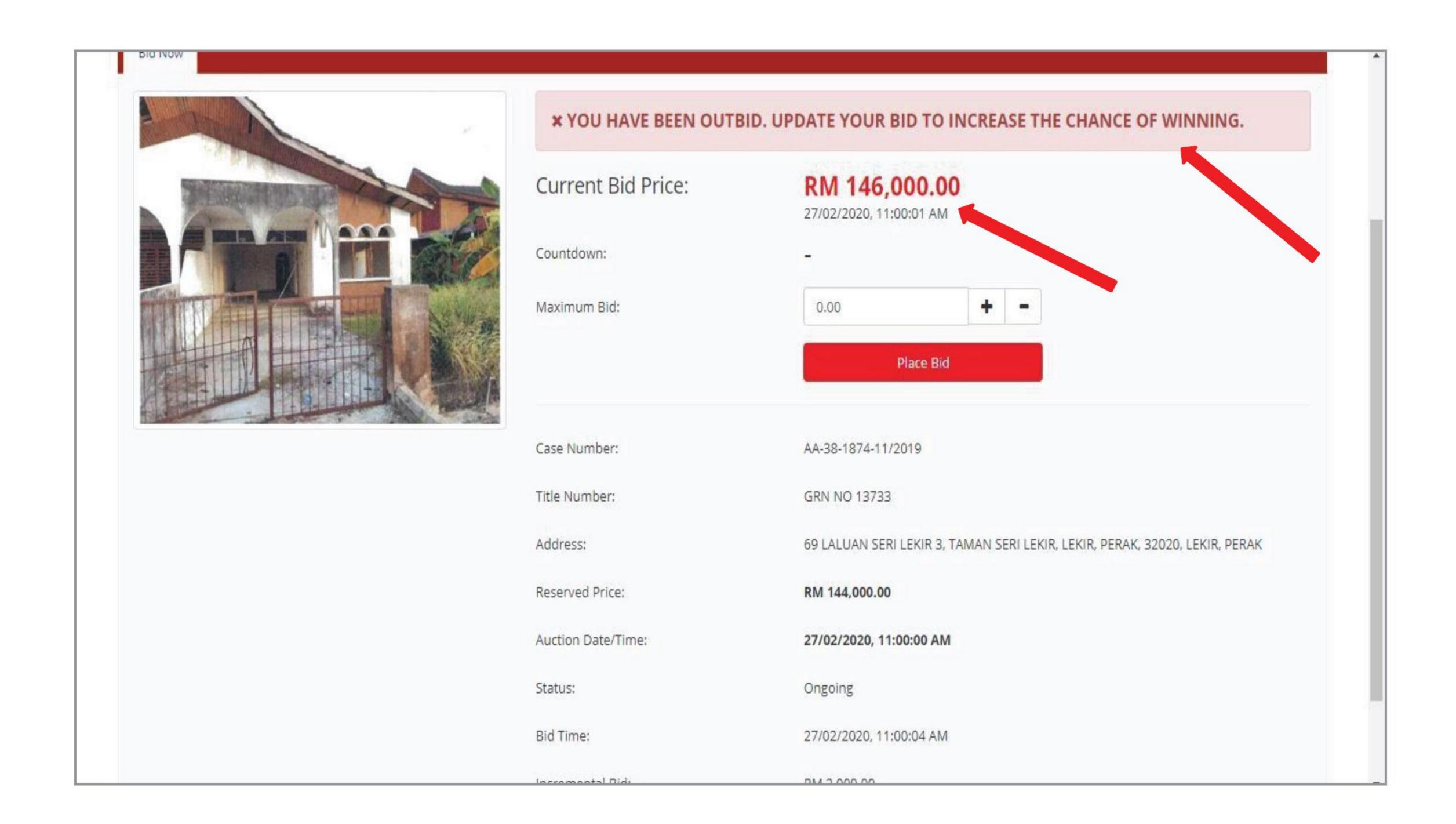

13.0 When the bidding begins, click [+] to increase the bid price. To lower the bid price, click [-]. Then, click Place Bid. [Figure 13.0]

14.0 If the bid price is lower than the other bidders, red-coloured notification and red-coloured bid price is shown. If the bid price is higher than the other bidders, green-coloured notification and green-coloured bid price is shown. Figure 14.0 shows an example, if the bid price is lower than that of the other bidders.

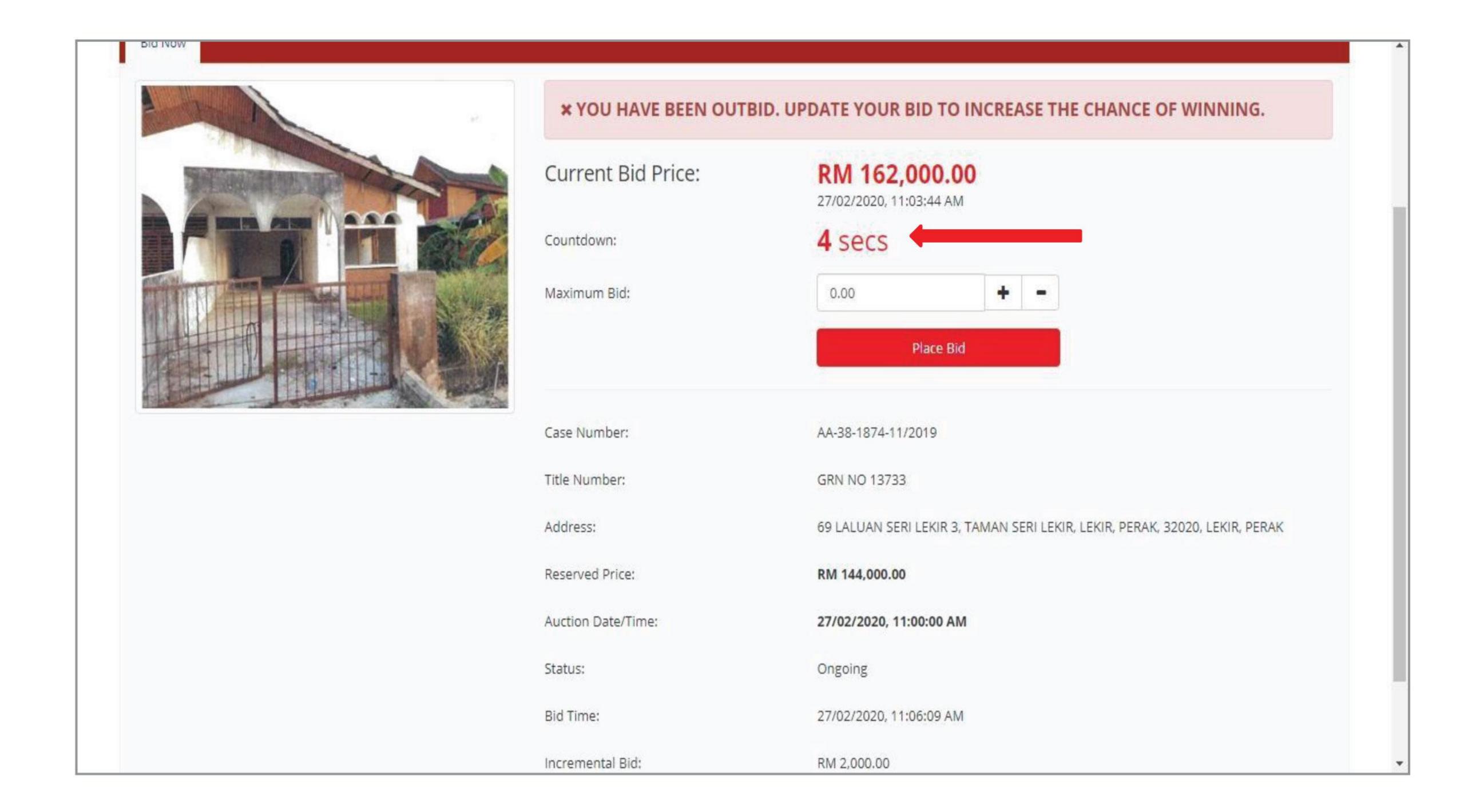

- 15.0 The maximum bidding session is 1 hour.
- 16.0 Bidding session will end in 30 minutes if no bid is made by any bidder.
- 17.0 Current bid price will be displayed.
- 18.0 Single bidder will be considered the successful bidder at the reserve price only. Single bidder MUST set a bid price if intend to buy the property.
- 19.0 In the event that there are only 2 bidders for the bid session, the bidder that intend to buy the property MUST set the bid price to 1 incremental bid price.

For example:

- reserve price = RM 100,000
- incremental bid = RM 1,000 Then, successful bidder must set the bid price to RM 101,000.
- 20.0 Countdown of 2 minutes 30 seconds will start each time the last bidder sets a bid price. The last 30 seconds of countdown will be displayed. [Figure 20.0] At this time, bidders may still increase the bid price if wishes to continue bidding.

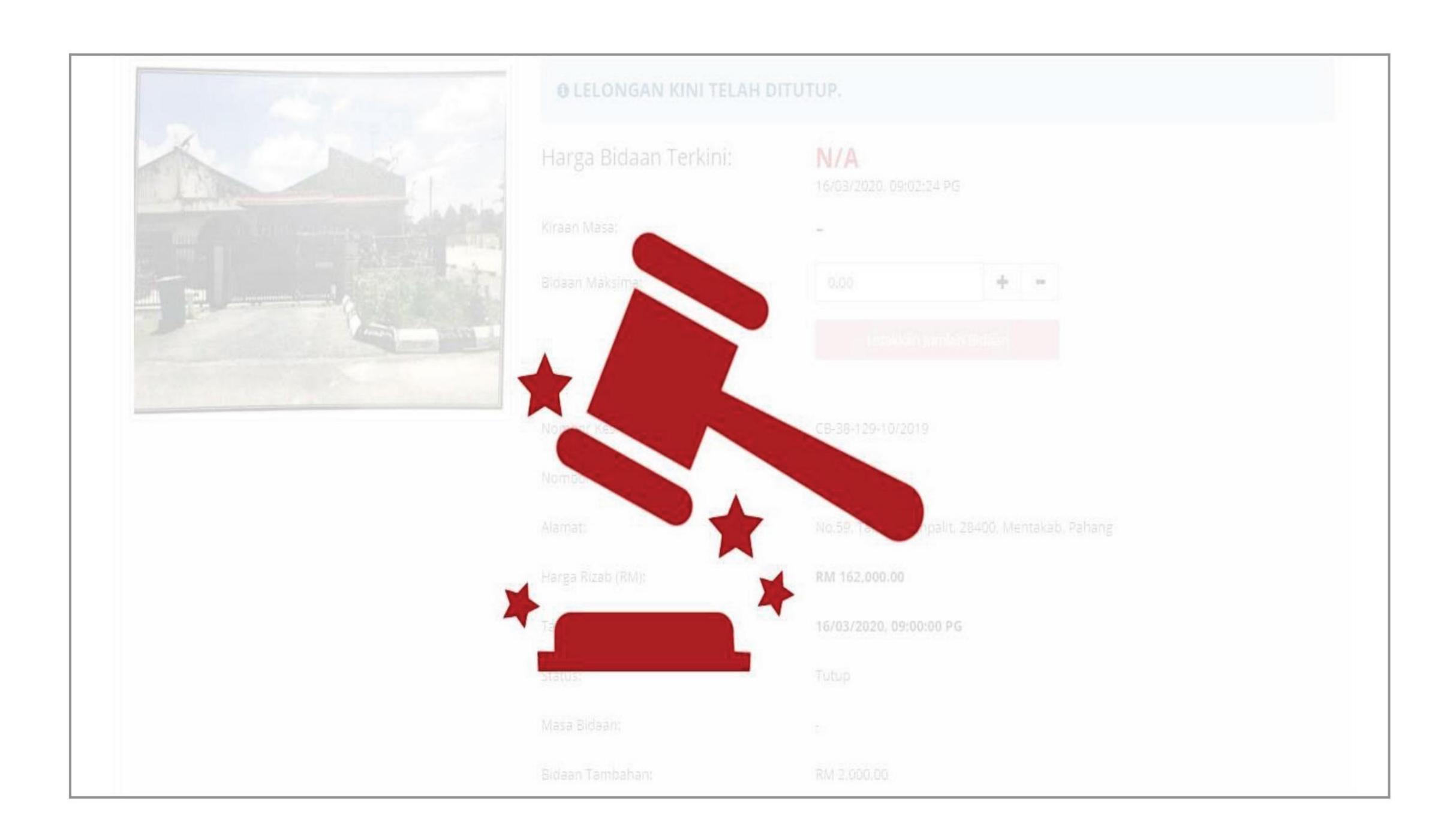




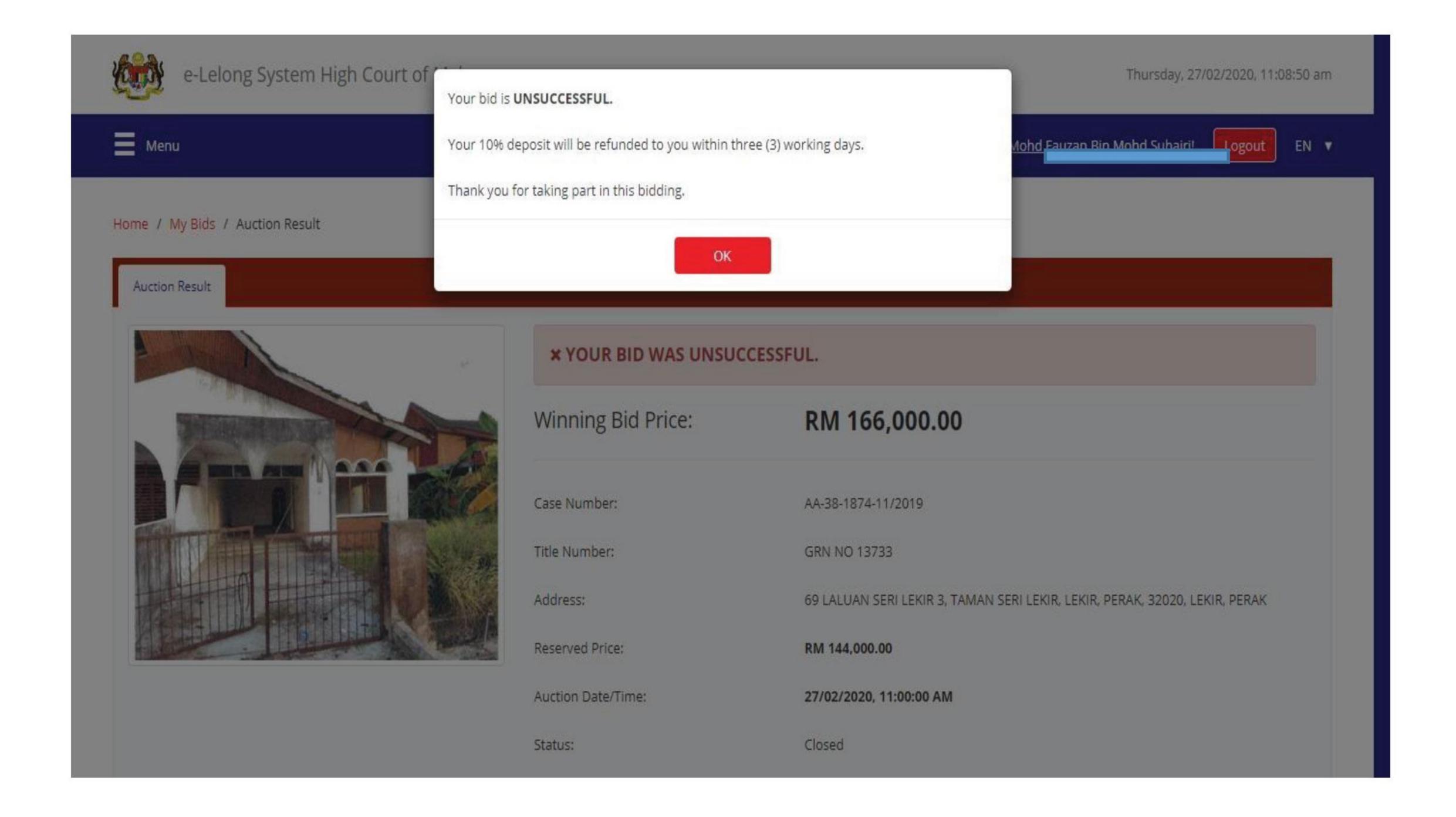

11.0 When the bidding session ends, hammer (gavel) will appear. Notification will appear. For successful bidder, Memorandum of Sale is ready for download. [Figures 11.0 - 11.1]

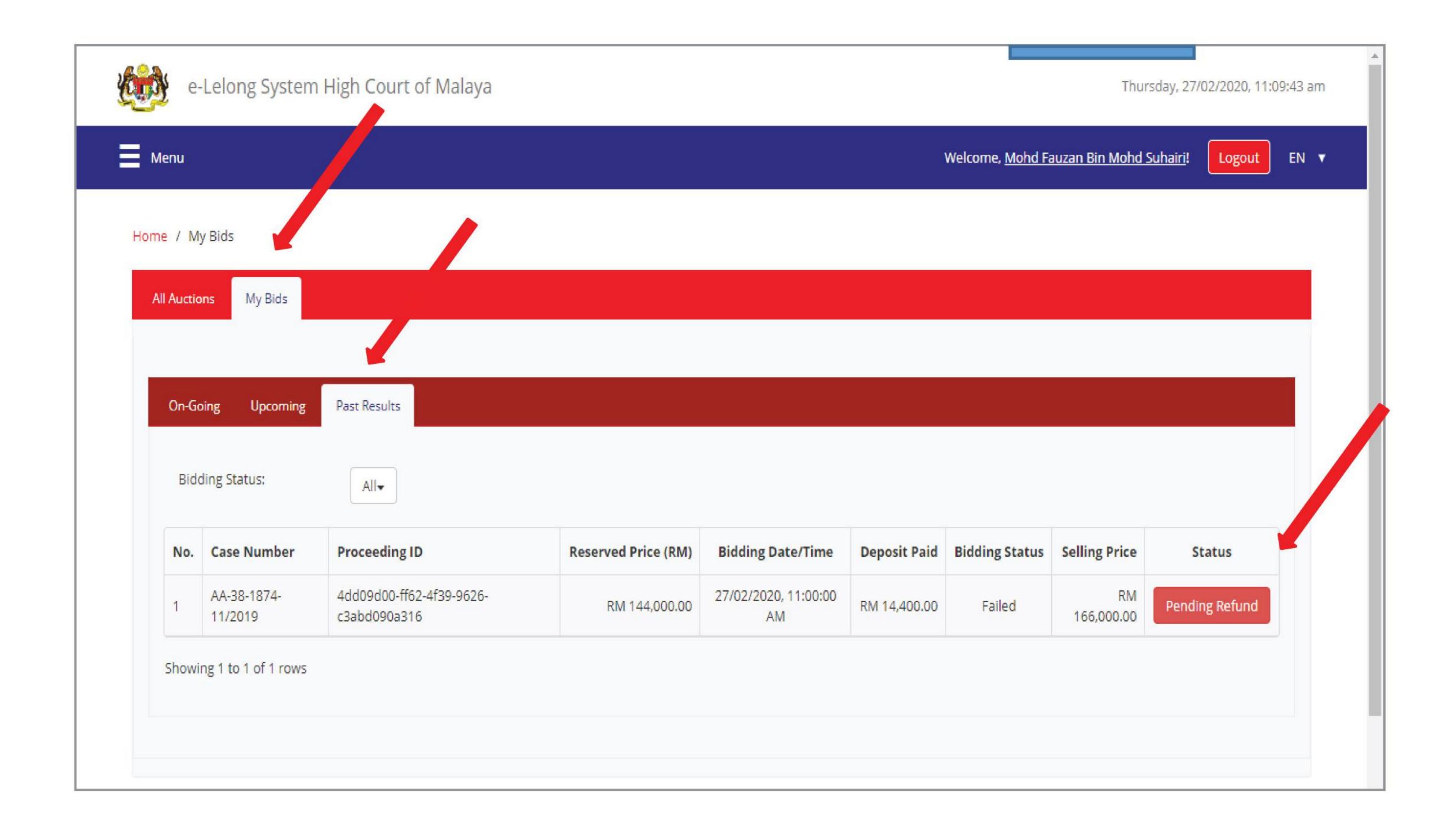
[Figure 11.1]

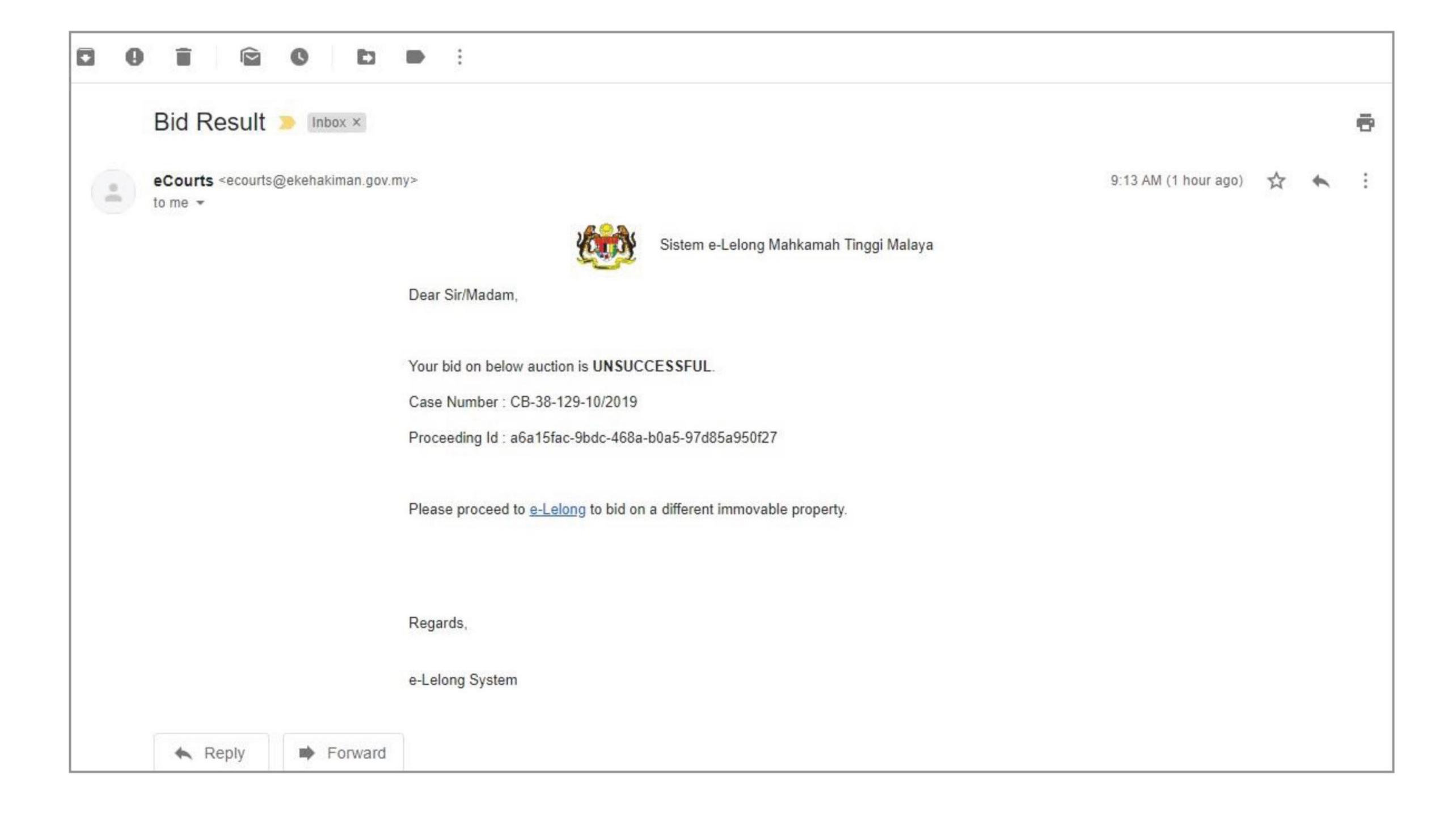

12.0 Unsuccessful bidder may reclaim bank draft at the relevant High Court of Malaya in a timely manner. For bidders that deposited bank draft by courier to Pusat Operasi e-Lelong, it will be returned by courier within 3 business days. [Figure 12.0]

13.0 Bidders that participated in the bidding session will receive notification of the bid result by email. Figure 2.2.9 shows email for unsuccessful bidders.

14.0 POST-BIDDING

- 14.1 Submit Proclamation of Sale and Memorandum of Sale to Inland Revenue Board (IRB) for stamp duty.
- 14.2. Submit stamped Proclamation of Sale and Memorandum of Sale to financial institution / banking institution for financing purposes.
- 14.3 Contact Plaintiff's lawyer / financial institution / banking institution for full settlement of the balance purchase price within 120 days of the date of the public auction.
- 14.4 Upon completion of the full settlement of the balance purchase price, submit Certificate of Sale by Court (Form 16F) to Pusat Operasi e-Lelong for processing.
