CONDITIONS OF SALE

1. RESERVE PRICE AND BIDDING AT AUCTION

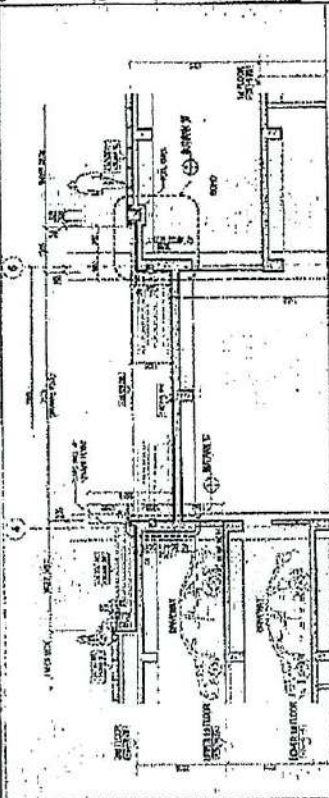
